Mr. Brandan Trahan led the Pledge of Allegiance, followed by the invocation led by Mrs. Anna Perry.


A motion was made by Mr. Jeff Jordan to approve the Official Board Meeting Minutes from the November 17, 2025, meeting, with a second by Mrs. Anna Perry. All were in favor; no objections were raised. The motion passed.

Mrs. Decuir presented the school's performance score that was recently released by the Louisiana Department of Education. The school's score is an 83.9 "B." Although the score decreased slightly from the previous year, there were some gains, along with some recognitions. We've put some things into place and are ready to work through this to bring our grade back up. She gave an overview of the new accountability system and explained how the grade would translate to the new system.

Mrs. Decuir asked the board to approve a tardy to class policy. While we have a policy for those who are late to school, there currently isn't one that takes into account students who are late for class. Under this policy, when a student receives 3 tardies, he/she will be assigned to after-school detention. Mrs. Anna Perry made a motion to accept the policy, with a second by Mr. Baham. All were in favor; no objections were raised. The motion passed.

Mrs. Decuir presented an updated transportation policy for the board to consider, which included students waiting in their vehicles until the bus arrived and came to a complete stop, as well as for the younger students to be walked to the bus. Mr. Baham made a motion to accept the policy, with a second by Mrs. Perry. All were in favor; no objections were raised. The motion passed.
