Mr. Evans motioned with a second by Mr. Judice to approve the Board Minutes from the Budget Hearing meeting on August 25, 2025, with no objections.

Mr. Evans motioned with a second by Mr. Jordan to approve the Board Minutes from the Special Meeting on August 25, 2025, with no objections.

Mr. Baham motioned with a second by Mr. Judice to approve the Board Minutes from the Regular Meeting on August 25, 2025, with no objections.
